# **Annual Exhibition and Convention**

## **Rules and Regulations for Exhibiting**

1. Exhibits must be the property of the exhibitor.
2. Entries must be made on the enclosed entry form. Copies are accepted. Exhibitors may enter as many exhibits as desired, depending upon availability. Complete one form for each exhibit. Entries will be accepted as received until all frames are filled. The exhibit chairman reserves the right to limit the number of frames per exhibit if necessary. If the exhibit is sold out, entry fees will be refunded.
3. Exhibits will be mounted in frames holding sixteen 8 ½" x 11" album pages. Sheet protectors are required. (Youth may enter 4, 8, or a multiple of 16 pages.)
4. Exhibits will be entered under the following classifications:

US & Foreign Pre 1900	Topicals
US & Foreign Post 1900	Youth
US & Foreign Postal History	Single Frame
5. Fees must accompany all entries. Fees are \$7.50 for up to five frames and \$2 per frame thereafter. Make checks payable to Waukesha County Philatelic Society and mail to Robert Henak, P.O. Box 170832, Fox Point, Wisconsin, 53217. Applications must be received by April 15, 2007.
6. Exhibits should be sent to Robert Henak at the address above. Exhibits not removed by the exhibitor will be returned by USPS Express Mail, uninsured, unless noted on the entry form and the proper fees enclosed. Exhibits must be received by May 1, 2007.
7. No exhibits shall be removed prior to the close of the show. Failure to exhibit will result in the forfeiture of the entry fee.
8. Set-up and takedown of the exhibits will be supervised by the Exhibit Committee. Exhibitors are encouraged to handle their own exhibits. Exhibit set-up time will be Saturday, May 5, 8 – 9:30 am.
9. Insurance is the sole responsibility of the exhibitor. Although due precaution will be taken to safeguard the exhibits, no responsibility of any kind shall attach to the Waukesha County Philatelic Society, their agents, officers, employees, volunteers or any other person authorized to perform duties in connection with the exhibits.
10. Judging will be on an open basis and the decision of the jury is final. A Grand Award will be presented. First, second, and third level ribbons will be awarded at the discretion of the judges.
