PROSPECTUS FOR NONCOMPETITIVE EXHIBITS

WISCOPEX 2010 invites ALL collectors to dig through their collections and accumulations to find philatelic material to share with the collecting public at the Wisconsin Federation of Stamp Club's annual convention and exhibition. The goal is to get the material out of the darkness of our closets and shoeboxes and into the light of frames where more people can enjoy the depth and breadth of our collecting interests. Whether a topic, a country, a set of stamps, or even a mini-exhibit on one stamp design — your participation is welcomed.

The WFSC recognizes that not all collectors have the time, material or even the desire to jump right into competitive exhibiting with 16 pages. WISCOPEX 2010, therefore, will have a special class of non-competitive 4 and 8 page exhibits. This is a way to share your love of the hobby and attract attention to the many facets of philately. Of course, we also encourage entry of full-frame (16, 32 or 48-page) non-competitive exhibits.

1. Each 8½ by 11 inch page should be mounted in a page protector and the exhibitor's name and address should be on the back of each page. **Applications will be due by March 15, 2010** unless prior arrangements have been made with Exhibits Chair, Robert Henak. There is no charge for these exhibits. Late entries may be accepted if space allows.

3. Although the 4 and 8 page exhibits and full-frame non-competitive exhibits will not be judged, a Wisconsin Federation judge will be available to critique the exhibit and offer suggestions regarding how to improve and expand the exhibit to a competitive level if the exhibitor so desires.

4. All exhibits to be mounted by the Exhibition Committee must be in the hands of the Exhibits coordinator **no later than April 9, 2010.**

5. **Exhibits are to be mailed to: Robert Henak, P.O. Box 170832, Fox Point, WI 53217**

6. All exhibits not mailed and that will be mounted by the owner must be brought directly to the show site on April 10, 2010, between the hours of 8 a.m. and 9:30 a.m.

7. No exhibit or any part thereof may be removed from the exhibit area prior to the close of the exhibition on April 10, 2010 at 5:00 p.m.

8. Exhibits will be received and held at the risk of the owner, and exhibitors must provide their own insurance. All precautions will be taken while your material is in our possession, but at no time shall liability be placed on the Federation, host club(s), show site, show committee, or their agents, officers, employees, volunteers or any other person authorized to perform duties in connection with the exhibits.

9. All entries will be returned as soon as possible after the close of the exhibition to those requesting return by mail. Exhibitors should designate instructions for return of their exhibits and enclose additional remittance to cover postage charges.
